

Chiropractic Pillars of Whole Being Care: A Healthier Path for Your Patients' Lives (1 CEU)

This course offers an introduction to the Whole Being Concept, underscoring the significance of chiropractic care through the lens of the Pillars of Whole Being: Investment, Replenishment, Nourishment, Movement, Adjustment, Contentment and Revitalization.

DCs will gain insight into the latest research on postural hygiene, nutrition, exercise, adjustment, mental health research and practical strategies to share with their patients for enhancing each pillar. Aligning with whole being care to foster greater resilience, adaptability, and balance, both for themselves and the patients they serve.

Contemporary Chiropractic Concepts—A Multi-Modal Approach (2 CEUs)

Brett Winchester, DC

Room: WW 28-30

Participants will be shown current research on the adjustment and how it applies to clinical practice. Over the years, many myths about the adjustment have been championed. Unfortunately, this has led to confusion and created a deficit in learning. This session will address all of these myths and how to reconcile them. Then, there will be a breakdown of the mechanics necessary to master adjusting. This will include intra-abdominal pressure as it relates to thrusting. Because being great at adjusting is a psychomotor skill, certain skills need to be learned and practiced to achieve mastery.

Next, the importance of dynamic palpation will be discussed. Dynamic palpation tells the chiropractor exactly where to perform adjustments and which planes of motion to include. Participants will be shown how to marry dynamic palpation to the adjustment. Finally, participants will be shown how to perform a variety of adjustments to key areas of the spine and how adjustments can be used with other modalities.

The Importance of Non-Surgical Solutions for Spine Discogenic Issues (2 CEUs)
